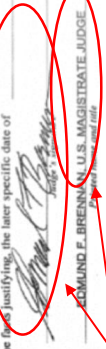

We will not do more than is legally required by an administrative warrant:
administrative warrants (forms I-200 or I-205) are not from a court; administrative
warrants DO NOT give agents the right to enter private areas without our permission;
we DO NOT have to say if an employee is working on that day or not;
we will video or record ANY actions federal agents take at this workplace.
